### Surgical Implant of the Auditory Osseointegrated System

The codes in this section may be reported by both the surgeon, ASC and hospitals

#### **Bilateral Billing Situations**

If two implants are implanted bilaterally in the same surgery, report this on the claim. Payers have different coverage and coding requirements for bilateral Ponto implantation. The following include some options for bilateral billing. Please check with your payer for specific coverage and coding guidelines.

### **Clinic Services And Supplies**

### Audiologist/Professional Services

The codes in this section may be reported by audiologists and other licensed clinicians for services related to preand post-operative analysis and rehabilitation of Ponto patients. This list may not include all services that may be offered to patients.



92587	Evoked otoacoustic emissions; limited (single stimulus level, either transient or distortion products)
92626	Evaluation of auditory rehabilitation status; first hour (can be used pre-op or post-op)
92627	Evaluation of auditory rehabilitation status; each additional 15 minutes
92630	Auditory rehabilitation; pre-lingual hearing loss
92633	Auditory rehabilitation; post-lingual hearing loss
92700	Unlisted otorhinolaryngological service or procedure. Example: May be used to cover fitting of sound processor

### **Medicare Billing Notes**

### Medicare has a number of rules dictating how certain codes may be billed. Some rules include:

92506, 92507 & 92508	May only be provided by an SLP. Medicare will not pay audiologists for these codes
92626 & 92627	Payable when billed by an audiologist or an SLP
92630 & 92633	Not payable by Medicare for any providers Medicare instructs providers to bill <b>92507</b> instead

Medicare's National Correct Coding Initiative (CCI) limits certain codes from being billed together, including several audiology codes. Some of these limits are avoidable through use of modifiers while others are strict limitations that cannot be overridden. Check with your Medicare contractor or payer for assistance clarifying these coding restrictions.

### System Supplies & Repairs

Repair and replacement codes in this section may require a DME license when not provided as part of a surgical procedure. Check with your local payer if DME billing requirements are unknown.

- L7500 Repair of Ponto device component(s), hourly rate

L7510	Repair of Ponto device component(s), repair or replace minor parts
L7520	Repair of Ponto device component(s), labor component, per 15 minutes

99070	Supplies provided by the physician above those usually included with the office visit or other services rendered
L8693	Auditory osseointegrated device abutment, any length, replacement only

### Softband

Code:	When providing device or service:
L8692	sound processor for attachment to headband

\* Some payers incorrectly classify the Ponto/Ponto Pro as a hearing aid. In these cases local policies may require the Ponto/Ponto Pro to be billed with a hearing aid code such as V5060, Hearing aid, monoaural, behind the ear

\*\*Payer have differing rule on proper use of modifiers. Consult your payer to confirm policies.
